Statutory Provisions Under Maharashtra Fire Prevention and Life Safety Measures Act, 2006, Rule 2009 & Amendment Act. 2023.

1. Under Section 3 of "Maharashtra Fire Prevention and Life Safety Measures Act, 2006" (hereinafter referred to as "said Act"). The applicant (developer, owner, occupier by whatever name called) shall comply with all the Fire and Life Safety measures adhering to National Building Code of India, 2005 and as amended from time to time failing which it shall be treated as a violation of the said Act.
2. It is presumed that you have completed the work adhering to the provisions under Section-3 of the said Act.
3. Under sub-section (3) of Section 3, it is responsibility of the Owner or the Occupier as the case may be, shall furnish to The Chief Fire Officer or nominated officer a Certificate in a prescribed form twice a year in the Month of January & July regarding maintenance of fire prevention and life safety measure in good repair and efficient condition as specified in sub-section (1).
4. Under sub section (4) of Section 3, no person shall tamper with, alter, remove or cause any injury or damage to any fire prevention and life safety equipment installed in any such building or part thereof or instigate any other person to do so.

We further certify under the Maharashtra Fire Prevention and Life Safety Measures Act, 2006, Rules 2009 and amended 2023 that the said buildings of the establishment are kept in good repair and workable condition. 06 months maintenance and inspection certificate in Form B of your license holder agency in this regard should be submitted to our office. Fire extinguishers shall be well

maintained and in excellent working condition at all times in accordance with the Provisional No-Objection Certificate. If the fire protection system is not maintained, trimmed, this "NOC." Please note that cancellation will be done without any notice and you will be solely responsible for any loss of life or property.

The condition mentioned in the "Provisional No-Objection Certificate" will remain unchanged. The undersigned reserves right the amend any additional recommendations deemed fit during the stage wise inspection due to the statutory provisions am ended from time to time and in the interest of the protection of the School. 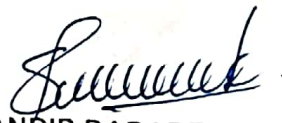
